It happens everyday on every worksite, but do our actions achieve the results we hope for? Are future behaviors actually being changed? Learn how to use simple, proven, communication skills to ensure workers are not only removed from an at-risk situation, but also appreciate the help that is offered to them. and learn how to avoid future unsafe behaviors. **Taking the Lead in Safety Supervisor Training**

Steve Rank, Executive Director of Safety & Health, IMPACT

*More project owners are requiring documentation of safety supervisor training on projects throughout North America. Many safety supervisor certifications servicing the construction industry are general in nature, and are not designed to address specific hazards for a variety of construction trades. The Iron Workers Internationals and IMPACT are developing a comprehensive "Ironworker Safety Supervisor Course" that will identify common hazards that Ironworkers supervisors encountered during steel erection activities, reinforcing and post-tensioning operations, precast concrete erection, cranes assembly and disassembly operations, and hoisting and rigging procedures. The "Ironworker Safety Supervisor Course" will be completed in 2018 and will be provided at our 156 training facilities for apprentices and journeymen upgrading throughout North America. This course is one of the safety initiatives that is part of the Iron Workers 2018 ZERO Incident Campaign commissioned by General President Eric Dean to prevent workplace incidents.*
